<b>Directions:</b>	<p><b>From Route 18 ( Piscataway/River Road):</b> Go approximately 3 miles on route #18 South and turn off on Route #1 south. Take <b>Route #1 south</b> to the second exit for Ryders Lane south. Proceed approximately 1 mile and turn right onto Washington Avenue. Go approximately 6/10's of a mile and you will see Milltown Municipal Complex on your right. Brookside Swim Club is located directly behind the Municipal Building.</p> <p><b>From Route 18 ( East Brunswick):</b> Take Tices Lane exit (Shop Rite/Kohls/Dick's Sporting Goods) and proceed approximately two miles to Ryders Lane intersection (Sunoco Gas/Dry Cleaners). Proceed straight through traffic light on to Washington Ave. Go approximately 6/10's of a mile and you will see Milltown Municipal Complex on your right. Brookside Swim Club is located directly behind the Municipal Building.</p> <p><b>From Route # 287 -</b> Take route #287 to exit #10 Easton Avenue, New Brunswick. Take Easton Avenue towards New Brunswick. Go approximately 3 1/2 miles and make a left turn on to Landing Lane. Turn right at traffic light on to George Street. Proceed 1/2 mile and take ramp on left to Route 18 South. Proceed 2 1/2 miles to Route 1 South. Once on Route 1 south follow the directions above.</p>

<b>Facility:</b>	Eight-lane, 25 yard pool equipped with non-turbulent lane lines, starting blocks, and electronic timing. It is recommended spectators bring your own blankets or lawn chair for use in the team area. Brookside will have a snack bar available with a complete breakfast, lunch & snack menu.	
<b>Official Rules &amp; Eligibility:</b>	Modified US Swimming Rules: All swimmers must be currently registered on an NJSDC summer swim team. Age is as of 6/30/13 (e.g., DOB 6/29/03, will be considered age 10 for the meet). A swimmer may enter a total of 4 events with a maximum of 3 individual events. All swimmers must have participated in at least 2 dual meets during the season in order to participate at Championships. There will be 10 teams represented, swimmers should not be entered in an event unless they can finish the event. As per NJSDC Rule book: <b><i>“All entries with NO TIMES or times that cannot be verified will be scratched and the fee forfeited.”</i></b> NTs will NOT be permitted. All swimmers must have an entry time.	

<b>Team Entries &amp; Work Assignments:</b>	Team entries must be submitted via email through Hy-Tek Team Manager or Team Unify entry files. <u>Two team timing assignments and one official will be required from each team for the duration each session (starter and referee experience will be needed for some).</u> <u>Timers please supply your own watches!</u> <b>TEAMS THAT DO NOT COMPLETE THEIR TIMING AND OFFICIATING ASSIGNMENTS WILL HAVE THEIR SWIMMERS SCRATCHED.</b> Send all official names (and ability to serve as starter/referee) to Charlene Glascock (charlene@marine.rutgers.edu)
<b>Entry Deadline:</b>	Electronic entries must be received in email by <b>6:00pm on Sunday, July 21<sup>st</sup>, 2013.</b> <u>Please include entry form as an attachment, if possible.</u> <b>Payment must be received by mail no later than Wednesday, July 24<sup>th</sup>.</b> All entries will be scratched if payment is not received. Entry forms and payment may be mailed to the below address: Scott Thompson 34 Howard Street Milltown, NJ 08850 swimriptide@optonline.net Make <b>one</b> consolidated check payable to Brookside Swim Club Meet Directors are forbidden to accept late entries for any reason. Entries MUST be emailed or submitted on Hy-Tek TM/Team Unify file by July 21 <sup>st</sup> . <b>** ONLY SCRATCHES may be made after this date.</b> <b>NO CHANGES!! NO EXCEPTIONS!!</b>
<b>Entry Times:</b>	Must include best times in <b>YARDS</b> . Conversions are acceptable. <b><i>"NO TIMES" or times that cannot be verified will be scratched and the fee forfeited.</i></b> NTs will NOT be permitted. All swimmers must have an entry time.
<b>Entry Fee:</b>	\$4.00 per individual event. \$10.00 per relay. Entry fees are <b>not</b> refundable.
<b>Awards:</b>	Trophies will be awarded to the top four teams based on scoring 7-5-4-3-2-1 and double for relay events. Medals will be awarded to the top 6 places in each individual event and relays.
<b>Check-in, Seeding and Scratching:</b>	Coaches' check-in sheets will be provided in the coaches' packet and will be available upon arrival. Events will be seeded at the meet after scratches. <b><u>SESSION 2 (12/unders) swimmers must MARSHALL</u></b> for heat assignments as each event is called. Failure to check in will result in the swimmer being scratched from that event. Failure to swim after checking in will result in the swimmer being scratched from their next event. <b>THERE WILL BE NO MARSHALLING FOR SESSION 1 (13/over)!</b>
<b>Waiver:</b>	Attached waiver and team fee summary must be returned with entry fees prior to deadline. In consideration of the acceptance of contestants entries the parents, guardians, and /or coaches of said contestants waive themselves, their heirs and assignees, any and all rights to claims for damages against NJSDC, Brookside Swim Club, or their agents or representatives, for any and all injuries which may be incurred by said contestants of this competition.
<b>Conduct:</b>	Coaches and their assistants will be held responsible for the conduct of their swimmers during the meet. It is expected that a "parent marshall" from each team will be in charge of each team's area during the meet and also that each team area will be cleared of all debris/garbage prior to departure from the club. Referee's whistle will be respected so that each swimmer has an equal opportunity to hear the starting command.
<b>Admissions:</b>	Each person entering the facility with the exception of coaches and officials will be charged \$4.00 (12 and under are free). Programs will be sold for \$3.00.
